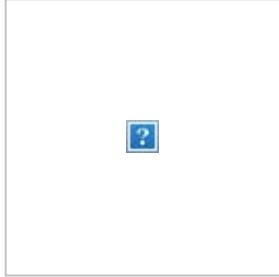

Pier Workshop, Saturday, August 26, 9:00 a.m., Council Chambers. The architect, consultant, and engineer will make presentations regarding reconstruction of the pier.

Three options will be presented: (1) rebuild as it existed; (2) rebuild with concrete foundation and wood deck, rebuild buildings as they currently stand, and (3) rebuild as in (2) and add a second floor for additional business space.

Financing options will also be discussed. It is anticipated that Town Council will choose a design at the workshop, which will impact financing and construction time, etc.
