The Town Council of Surfside Beach met January 5, 1965 at 7:30 P.M. Minutes of previous meeting were read and approved.

The County Men have been dredging and cleaning out all the drainage ditches in Surfside. There is still a few to be finished of which they expect to finish within the next month.

Mayor Harrison read a Public Health Ordinance pertaining to the cleaning of these ditches. One resident refuses to let the men clean the ditch beside his house, but with this Ordinance the process will continue.

Mr. William Zumstein of the Federal Census is conducting the Census needed by our Town to receive any State revenue. An official enumerator from the Federal Census Bureau is required to conduct the project. Helping him are, Mrs. Nancy J. VanCleave, Mrs. Robert Shirk and Miss Brenda Shirk.

The Note at Peoples' National Bank was paid off December 30th. Mr. Clarke expressed his desire to transact further business with us if we thought necessary. The Council voted unanimously to borrow a sum of \$7500 to continue the coming years operation. The following certificate was signed and taken to Mr. L.N. Clarke:

We, T.J. Harrison, R.C. Freeland, Ernest H. Lee, William O.Martin and Leo Rogers, hereby certify that the following is a true copy of a Resolution duly passed at a meeting of the Town Council of the Town of Surfside Beach, held on January 5, 1965, at 7:30 P.M. The Resolution is as follows:

Be it resolved, that the Town Council of the Town of Surfside Beach be, and the same is hereby authorized to borrow a sum not to exceed the sum of Ten Thousand (\$10,000.00) Dollars, at the best interest rate obtainable, from Peoples' National Bank, Myrtle Beach, S. C., in anticipation of an anticipated revenue for the calendar year 1965.

This Resolution was duly moved, seconded, and was unanimously adopted by the Town Councilof Surfside Beach, S.C.

We hereby certify that the sum of Ten Thousand(\$10,000.00) Dollars does not exceed 75% of the anticipated estimated revenue to be derived from property taxes for 1965.

An Ordinance has been passed previously to the effect that owners must clean their property. The Sanitation Department has been trying a tractor with a rotary cutter attached. This tractor seems to be doing the kind of work for which it will be needed. Ernest Lee motioned we purchase the tractor, all were in favor. The cost being \$1408.80. Payments will be once a year for two years.

Our new Fire House is almost completed and should be ready for the Firemen to move into at their next meeting.

A meeting was held with the County Delegation at the Charcoal Hearth. This was a very successful meeting, the following was recommended by the Delegation:

Recommended that we levy a garbage fee as all the beaches have done. \$10 per kitchen plus \$5 for each additional not to exceed a total of \$25 except for motels.

Recommended we levy a privilege license on all transit rentals of \$5 per unit. This works in conjunction with sales tax rentals.

Recommended that we may up taxes 10 more mills. We can increase up to sixty mills without a referendum.

Recommended that we have a revaluation board in conjunction with Jack Gerrald, revaluate the property here. Value hasn't been raised since the development started.

Recommended that we officially send a letter to delegation asking for legislation for length of term of Mayor and Council and also have it set up for a run off if needed.

Horry County cannot lend any money to any town by law but reccommended that we contact the Director of S.C. State Sinking Fund Division. Mr. Furman McEachern, Columbia, S. C. and apply for a loan to build city hall and police station. Senator Stevens reccommended that the Mayor and whole Council meet with him and the delegation in Columbia about a week after they convene January 15th, 1965. He will make an appointment with the proper authorities.

Recommended that we send in a request for farm to market roads and sidewalks for Surfside Drive and Boulevard this will be on milage basis and they will do everything they can to give us our fair share.

A letter is to be written to Jack Gerrald, County Auditor, asking when the revaluation is to be.

The two part house which has been discussed quite frequently will be torn down beginning this week. Mr. J.W. Chitwood, owner, has not notified Town Hall either way of his intentions. The Sanitation Dept. Supervisor will hire two men to help with this operation.

Calhoun Realty gave a map to the Town Hall showing the land which is to be annexed, this blends with the map already in Town Hall.

Council discussed the possibility of obtaining a police radio outfit, if one could be found at a reasonable price. Councilman Rogers is to help with this correspondence. The electrical test for electricians has been completed. A test for plumbers will be compiled shortly.

A special Council Meeting will be held for the purpose of setting up a budget for the coming new term which begins in March.

Mr. Jack Gerrald, County Auditor, answered our letter about re valuation. It is to be in 1966 again. The valuation is every four years. Council wants this valuation this year and as soon as possible.

A fee was mentioned regarding fires outside the Town Limits. Our truck is not insured outside the limits. A letter is to be written to Mr. Carl Dickert asking the proper procedures on this situation.

Information has been received about a set of Code of Law Books of S.C. These books can be obtained for \$83 from the State Library in Columbia. Correspondence will be sent asking if Code of Laws will be published before 1972. If not, Council will purchase the 1962 set.

The State Legislature will be written asking for paved streets and sidewalks for Surfside: The following was recommended: 3rd Ave. South, Dogwood Drive North, Pine Drive North, Cedar Drive North and sidewalks on Surfside Drive and on the Ocean Boulevard four blocks North and South. In the same letter, Council asks for a change in the term of Mayor and Council. Mayor for two years, highest two Councilmen two years and lowest two Councilmen for one year. An election would therefore be held every year. Also, a run-off is to be set up in case of a tie.

The Finance Committee, composed of Jay Layton, James Priest and Joe Lane, of the Fire Department came before Council with information on Fire Fighting equipment. They wanted to know if Council would pay half of the amount if they could pay half. Firemens' hats, hip boots, fire-proof coats and gloves will be in the order. The amount Council will have to pay will be between \$160 & \$170 R.C. Freeland made the motion Council go half way with the Firemen, W.O. Martin seconded, all in favor.

Mayor Harrison mentioned the idea of having open house when the Fire Hall is completed. Downuts and coffee to be served.

The election for another Mayor and Four Councilmen will be in March. Books will be open for fifteen(15) days prior to the election for candidates wishing to run for office. All persons must be registered thirty (30) days before election to be eligible for voting. Dexter will be advising voters as to proper procedures.

Zoning was the biggest topic of the meeting. Several additions and eletions were made before it was passed by Council. On page eleven (11) of the Zoning Book, the topic "Buildings" Section 2, the sentence was added: "This applies to all land West of Dogwood Drive." On page fourteen (14) under "Building Site Area" the square footage was changed: It stated previously:"The minimum building site shall be one lot or parcel 22,500 sq. ft. in area" - Changed to "10,500 sq. ft." Another sentence was: "Such parcels shall have an average width of at least 100 feet", - Changed to 65 feet. Another change on the Zoning Map was: Lots 1,2,3,4 Block 26-A previously was in an R-2 Zone - Changed to R-3. Mayor Harrison read the Zoning Ordinance, Purposes and Enacting Clause and the Short Title. R.C. Freeland made the motion Council accept the Zoning Map and Zoning Book as it stands at the present. W.O. Martin seconded the motion , all in favor. Ernest Lee was absent from this meeting but left word for his vote to be counted.

A Board of Adjustment was chosen: Each man was called and accepted the position. R. G. Smith, E. J. Servant, Neil Yongue, Pete Dry and Amos Green. This Board will hear any further argument or request for change in Zoning.

At the previous Council meeting a fee was set for the Surfside T.V. Repair Shop for \$25. This is to be changed to \$10 the same as other T.V. Repair Shops are paying. A refund of \$15 will be given Mr. W.G. Baker, owner and operator.

Wesley Hughes Grading Company will be contacted as to the clearing of land which is required by our Town Ordinance. Letters will be writen as to prices on this clearing. R.C. Freeland will leave some of his business cards here in the office and the owners will make the decision as to who will clean his land.

Leo Rogers made the motion Town Hall be moved up to the Fire Department Building. He suggested a petition could be put across the back and close it off from the Firemens' Hall. No seconds was heard as to this motion therefore the motion was not carried.

An Ordinance to Establish & Municipal Planning and Zoming Commission

An Ordiance to provide for the <u>Town of Surfside Beach</u> Planning and Zo : (name of city) ing Commission and to repeal all ordinances in conflict herewith.

Be it ordained by the <u>Town Council</u> of the Town of <u>Surfside Beach</u>, South (governing authority) Carolina, in order to guide and accomplish a coordinated and harmonious development of the municipality which will, in accordance with existing and future needs, best promote the public health, safety, morals, order, convenience, prosperity, and the general welfare, as well as efficiency and economy in the process of development, that the <u>Town of Surfside Beach</u>, Planning (name of city) and Zoning Commission, hereinafter referred to as the Planning and Zoning Commission, is hereby created and established as authorized by the General Statutes of South Carolina, Chapter 10, Article 2, Section 47-1021, and that said Planning and Zoning Commission shall be organized, empowered and governed by the following previsions:

SECTION 1. MEMBERSHIP

The Planning and Zening Commission shall consist of <u>five(5)</u> members to be (up to 9) appointed by the City Council of the City of <u>Surfside Beach</u>. The Chairman of the governing body of <u>Herry</u> County shall be an ex officio member of the Planning Commission. The terms of office of the members shall be for four year, except that, of the <u>five (5)</u> members first appointed, <u>one (1)</u> shall be appointed for a term of one year, <u>one (1)</u> for two years, <u>one (1)</u> for three years, and <u>two (2)</u> for four years, except that the term of office for the supervisor or other head of the governing body of the County shall be coextensive with the term of his county office. Any vacancy in membership shall be filled for the unexpired term by the Mayor who shall also have the authority to remove any member for cause, on written charges, after public hearing. All members shall serve without compensation but may be reimbursed for actual expenses incurred in connection with their official duties.

SECTION 2. ORGANIZATION; MEETINGS, RULES, STAFF, AND FINANCES The planning and Zoning Commission shall elect a Chairman from among the appointed members and fill other offices as it may determine. The term the Chairman and other officers shall be one year with eligibility for a election. The Planning and Zoning Commission shall adopt rules for the transaction, findings and determinations; and shall keep a record of its recommendations, transactions, findings and determinations; and shall he at least one regular meeting in each month. All meetings of the Plannin and Zoning Commission at which official action is taken shall be open t the public and all records of the Commission shall be a public record.

The Commission may appoint such employees and staff as it may deem nece for its work and may contract with the Division of Community Planning, Development Board, and consultants for such services as it may require. expenditures of the Commission, exclusive of gifts, shall be within the amounts appropriated for said purpose by the <u>Town of Surfside</u> <u>Town Cou</u> (Gov. Bod

SECTION 3. GENERAL POWERS AND DUTIES

From and after the time when the Planning and Zoning Commission shall h organized and selected its officers and shall have adopted its rules of procedure, then said Commission shall have all the powers, duties and r ponsibilities set forth in the General Statutes of South Carolina.

In general, these powers, duties, and responsibilities shall include:

1. Acquiring and maintaining in current form such basic information materials as are necessary to an understanding of past trends, present ditions, and forces at work to cause changes in these conditions; 2. Preparing and from time to time amending and revising a comprehensive and coordinated plan for the physical development of the area.;

3. Establishing principles and policies for guiding action in the development of the area.

4. Preparing and recommending to the City Council for adoption ordinances promoting orderly development in accordance with the comprehensive plan;

5. Determining whether specific proposed developments conform to the principles and requirements of the comprehensive plan for the growth and inprovement of the area;

6. Reviewing and recommending to the City Council any needed changes in the Zoning Ordiance and the map of the City of Surfside Beach, S.C.

7. Preparing and recommending for adoption Subdivision Regulations and to administer such regulations.

8. Keeping the City Council and the general public informed and advised as to these matters.

SECTION 4. REPEAL AND DATE OF EFFECT

All ordinances in conflict herewith are repealed, and this ordinance shall take effect from and after its passage, this <u>14</u> day of <u>January</u> 1965, the public welfare of the City of <u>Surfside Beach</u>, South Carolina, demanding it.

SECTION 5. VALIDITY

Should any section, or provision of this ordinance be declared unconstitutional or invalid for any reason, such declaration shall not affect the validity of the ordinance as a whole or any part thereof which is not specfically declared to be invalid or unconstitutional.

ADOPTED: January 14, 1965 ATTEST

The Town Council met January 21, 1965 at 7:30 P.M. Minutes of previous meeting was read and one correction made. The minutes stated that in the letter to State Legislature we wanted paved streets on Dogwood Drive North; should have been North and South.

Mr. Drake Rogers has expressed an interest to become a rewident of the Town. He wants his Plantation Motel and Resturant in the Town Limits. When Mr. Rogers is ready to take action, he can present Council with his request.

It has been suggested a light be installed at the end of 17th Avenue North. The area is very dark, also the inside curve is gradually giving way and is very hazardous. A letter will be written Marion Hart asking if he will add another pipe making this curve wider. R.C. Freeland made the motion this letter be written, seconded by Leo Rogers.

A police radio system will be purchased as so on as possible. Cliff Hammond is to let us know when the radio will be available. A high frequency used radio will have a base station and one in the car. This outfit will cost approximatkey \$700. We will have to use FCC licenses of other Grandstrand Towns until we can get one of our own. Letters will have to be on file in the Town Hall from other Towns stating we can use their licenses until our comes through. We will not be connected to the County Police, however, if the occasion should arise that we need them, Myrtle Beach Police can get in touch with them for us. Council voted unamiously to purchase this equipment.

A license fee was set for Dugstores and Furnitures Stores at \$50.

Correspondence has been received on the Price of aset of 1962 State Code of Law Books. W.C. Martin made the motion the books be ordered at the price of \$83; this will include a 1964 supplement. Ernest Lee seconded the motion all in favor. James A. Calhoun, II will be written asking if he will pick these books up for us, therefore saving the shipping charges.

Discussion about repairing the swash at 3rd Avenue North: If the contigous land owners would go in together and repair this swash properly, it would function as it should for years. In the near future these people will be contacted asking if they will do this.

Coastal Properties has given an enlarged map of the Dogwood Lake Extension Section to Town Hall. Thismap shows a diagram of how each house should be constructed on the lots so as to have the correct footage.

Certification of our population has been received from the Federal Bureau of Census. The following was reported:

At the present time Surfside cannot get a resident Highway Patrolman. However, more correspondence will be sent concerning one in the future. This information was given to us through a letter from Captain Thompson of the S.C. State Patrol.

Discussion was held as to whether to trade the four-wheel army truck for a 148 Dodge truck. This dodge truck seems to be what the Town needs to mount the water tank which we have. Several of the Councilmen will inquire further on this before any trading is undertaken.

An election date was set to elect another Mayor and four Councilmen. The date is March 9, 1965 (Tuesday). All candidates filing for these offices will do so February 22nd through March 2nd. Books will be closed on the2nd. The County is to be contacted as to when the books will be open and closed for persons to register for voting privileges. It has been mentioned that voting will take place at the Fire Department Building. Fees for candidates filing are \$5 for Councilmen and \$15 for Mayor. The Town Council met Thursday February 18, 1965, in the Town Hall. Council discussed the cleaning up of the land owned by the Town. Council agreed that Town Books should be closed with the fiscal year ending on December 31st. Also, that Foster Smith should be contacted as to the auditing of Town Books. Purchase orders are to be made up and nothing is to be purchased without an authorized signature.

A letter will be written Marion Hart as to the drainage on 17th Ave. to Ocean. R.C. Freeland and Chief Shirk will go over to Conway and contact French Collins and talk with him personally about the water situation we have.

W.O. Martin will be in charge of the Fire Department as to their reporting any matter to be taken up with Council and etc. Any complaint will be taken to Bill and he will bring it before Council. He is to set up a meeting with the Fire Chief, Assistant Chief and Secretary for the purpose of telling them to report all activities whatever, to Council once a month.

Mr. Jones of the Myrtle Beach Communications, will be notified to install the police base station in the present Town Hall office.

The Town Council of Surfside Beach met March 11, 1965 at 8:00 P.M. This was the first meeting after Election on March 9th. Minutes were read of previous meeting. One correction was made. It was stated in minutes of February 18, 1965 Mr. Freeland would clean and repile stumps for \$50. This fee was \$74.

Winston Ballard was present and stood before Council expressing his thanks for the business the Town gave him from April 1964 through February 1965.

Col. Roberts was present and wanted to know of the procedures on drainage around his house and property. Mayor Harrison assured him everything possible was being done to drain the water. Jay and his men have begun digging by hand on 16th Avenue North so as to start the flow toward the ocean.

J.A. Fuller, E.J. Servant and Amos Green were also present at the meeting. Mr. Fuller discussed the new annexation and the benefits that we were to give them. He also brough up the subjects of sewage, dogs running at large and the water system at lower end of Surfside. It was also discussed about the opening of the alley behind the Fire House. Mr. Fuller feels the Town should bear the expenses in this operation.

This portion of the meeting was adjourned and all left except Council.

An Ordinance will be sent to Horry Delegation authorizing Council to borrow \$15,000 at 4% interest for a period of 5 years for City Administration Facilities. W.O. Martin made the motion to borrow this amount, Ernest Lee seconded, carried by all. Before any construction begins, bids will be taken.

Several roads in our Town have become hazardous and need lights burning all night to signal cars. Leo Rogers made the motion Council purchase one dozen flambeaus at the rate of \$21 per dozen. Bill Martin seconded the motion, carried by all. These will be ordered from Cities Supply in Sumter, S.C.

The Primary Election was held March 9, 1965 and the results were as follows

T.J. Harrison 89 votes for Mayor Evans M. Bunch, Jr. 53 votes for Mayor

Robert Blanton - 34; R.C. Freeland - 116; Ernest H. Lee 98; W.O. Martin 103;

Col. Wagner Roberts - 43; Roy J. Stroupe -89; Jim Squires - 85. The Mayor and highest two Councilmen will serve for two years the lowest two councilmen for one year only. R.C. Freeland was automatically Mayor Pro tem.

Voting was also for the annexation of the Ocean Pines, Sparrow Sub Division and North Garden City Sections to the present limits of our Town. The vote on that is as follows: in the proposed area - For Annexation 10; Against Annexation 4. In the Town of Surfside the figues were: For annexation 131; Against 11. A General Election will be held on March 23, 1965 to accept these. Ernest Lee motioned this Election be held, W.O. Martin, seconded.

A letter will be sent to Secretary of State stating the new boundaries of the Town since annexation. Council accepted the vote count and the annexation of the new area to our Town.

A letter and an Ordinance will be sent to the Census Bureau stating the annexation was passed. R.C. Freeland made the motion Council accept the Annexation, seconded by Leo Rogers and all in favor.

A letter will be written J. W. Jenerette asking Legislature to allow tax collection on the newly annexed area as of January 1965.

Council authorizes police protection and garbage collection in the new area immediately.

A letter will be written Hughes and Murdock stating they should not rebill anyone inside of the new limits for garbage collection when their contracts expire.

Fleming Jones was contacted as to auditing Town Books. Council is to let him know if they want him for this operation.

Council unamiously agreed to refund the Town Cherk \$10 which she paid for her Bond for the past year. Inquiry is to be made with Bryan, Gandy, Smith in Myrtle Beach about a Blanket Bond Insurance Coverage.

Dexters' salary will be fixed and presented him as momento of his years work.

Council authorized 150 ballots to be printed for the General Election.

BE IT ORDERED AND ORDAINED BY THE TOWN OF SURFSIDE IN COUNCIL ASSEMBLED AND BY THE AUTHORITY THEREOF:

> It shall be unlawful for any person to fire, shoot, discharge or cause to be discharged any fireworks in the Corporate Limits of Surfside Beach. A penalty of not less than \$20 nor more than \$100 will be filed against the person violating this law.

W.O. Martin made the motion this ordinance be adopted, Ernest Lee seconded the motion, carried by all. A Business License to sell fireworks will be \$100 per year.

Mayor Harrison received a letter from the Surfside Development and Improvement Association stating they plan to give tourist packets of material, pertaining to our Town. They have asked the Town to contribute a letter giving some laws, information about the Town operation and anything else that would be interesting and informative. This packet is to be completed by April 15th.

Surfside Cleaners has filed a permit to erect a sign directing traffic to the drive-in window. Council has ok'd this sign. A discussion was on the height of signs in the Town. Council declared all signs should be at least nine (9) feet off the ground. Signs this height would lessen traffic accidents. Letters are to be written to all Sign Co's., Realty Co's and etc. notifying them of the regulations. An ordinance was passed to that effect. BE IT ORDERED AND ORDAINED BY THE TOWN OF SURFSIDE IN COUNCIL ASSEMBLED AND BY THE AUTHORITY THEREOF:

Any person erecting an outdoor advertising sign in the Corporate Limits of the Town of Surfside Beach, shall fill out an application from Town Hall, approval of such sign will be given by Council. All signs erected must be at least nine feet (9') above street level so as not to cause traffic hazards. Anyone violating this law shall be guilty of a misdemeanor and shall be fined a reasonable amount.

Blanket Coverage Insurance is to be taken with Bryan,Gandy and Smith Insurance Agency. Coverage will be for Town ClerkyTreasurer, Chief of Police, Sanitation Supervisor, three garbage collectors, Building Inspector, Mayor and four Councilmen. This policy will be the "Honesty Policy" covering each of these for "2500 at the rate of \$53.55 per year. W.O. Martin motioned this be purchased, seconded by Roy Stroupe carried by all.

A Privilege License for summer rentals will be charged all individuals, companys and etc. beginning this summer season. the license will be \$5 per unit or each sleeping unit will be charged, this does not include year round rentals. R.C. Freeland motioned this be passed, seconded by Roy Stroupe.

The minimum fee for Building permits will be changed from \$5.00 to \$7.50. A fee of \$7.50 will be charged for building operations \$200to \$2000 and \$1 for each additional thousand. Any building up to \$200 is permissable without a building permit. Also, before a building permit can be obtained an entrance pole must be erected as well as having water tap and plat of land. R.C. Freeland motioned this be changed seconded by Roy Stroup, carried by all.

The Mayor and R.C. Freeland plan to make a trip to see Arthur Parsons about getting roads paved here in Surfside.

R.C. Freeland made the motion Garbage assessments be mailed to all residents, charging them \$10 per kitchen each additional kitchen \$5, payable as of May 1st. If not paid by June 1st, a penalty of \$5 added. If they still don't pay, no more garbage collection. Each rack will be numbered and a corresponding number in Town Hall, so as to know who has paid. Police is to notify all persons about getting garbage racks. Ernest Lee seconded this motion.

An Advisory Board to Mayor and Council was nominated. A.V. Manley, Collie Prescott and C.A. Nooney. These men are to report to Council about any complaint or any problem that anyone has and get it ironed out. W.C. Martin motioned to accept these men, motion was carried by all.

In the future when persons or clubs wish to use the Fire House, Council will O.K. the meeting and send them to Fire Chief to get and O.K. from him also.

Council raised outside garbage fee \$10 over last years fee. Residents who previously paid \$30 per year will pay \$40. Resturants and Animal Hospital paid \$50 now \$60. W.O. Martin motioned this be raised, R.C. Freehand, carried by all.

It was discussed about a private phone for the Chief of Police at his house. The Mayor will contact Mr. Hale as to this. Also, the Chief would like an entrance to the Town Hall after the base police radio is installed. This will be taken care of.

Councilman Stroupe will be in charge of all Police Detail; W.O. Martin over Sanitation and Fire Department; R.C. Freeland over Streets and Lights; Ernest Lee over tax structure and Business License.

The hours for the Sanitation Department were discussed. Council set the following hours:

June, July, August - 7:A.M. - 11:00 12:00 - 4:00 P.M.

Dog tage will be issued yearly and all dogs must have current tags.

He further stated "The Surfside Water Works was a very feasible investment for the Town to undertake," It was stated only one improvement would be absolutely essential that of installing & new well on the North end of Surfside.

From 13th Avenue South to Melody Lane, Southern Gulf Utilities operate a water system. Southern Gulf cannot add to their present set up or repair without the Towns' approval. It is anticipated the system can be purchased along with the S.W.Works The Town does not have a franchise with any firm. It will not be necessary to condem the Surfside W.Works, but an election will be necessary for the residents to vote. Also, it is a requirement to float bonds. If the water works were to be built the only requirement would for Council to borrow the money and begin.

Mr. Menefee suggested the figure of \$250,000 to be borrowed. This would purchase the existing water works and install the new well on the North end. Mr. Menefee will give us a definite answer on the loan after talking with Mr. Bryan and verifying several items.

Council approved the application but will have to know which section in the Business Area he intends to set it up and must check and approve the type of safety precautions used. License will be approximately \$100, depending on what all is involved in the business.

A Franchise from SCRSA was read and discussed for the second time. This is a very feasible franchise and will be discussed again at next months meeting.

The Town Council of Surfside Beach met at 6:30 P.M. on December 21st in the Town Hall. Minutes of previous meeting were read and approved.

It has been called to the attention of the Council that junk cars are being kept in the yard of Allard Blanton. This is an R-1 Section and it is only for single dwelling homes and not for junk yards or used car lots. Mr. Elanton is to be notifed to remove these at once. Section 10-12 states that he violating a Town Ordinance.

Signature for the Bond Election are coming in very good. When the figure exceeds 609 reports will be filled out and mailed to 'Sinklar-Gibbs-Simons of Charleston, they in turn will set up the Election for the Purchase of the Surfside Waterworks.

W.O. Martin is to get in touch with the Fire Department and see that a log book is being kept and that copies are made to be turned in to Town Hall for permanent records.

The Surfside Rescue Squad is now Incorporated. The Town is no longer responsible for their activities or debts. An ordinance was passed as a continuation to Section 5-5 in the Town Ordinances as follows:

Section 5-5.1

Violation of Section 5-5 shall be a misdemeanor and shall be punishable by a fine of not more than \$100 or 30 days imprisonment.

Section 5-5.2

Violations arising under Section 5-5 shall be regarded as separate violations for each day following commencement of construction and shall be punishable as separate offense as set forth under the penalties set forth in Section 5-5.1

In the event that construction shall be commenced prior to obtaining a building permit, the builder or architect shall furnish evidence satisfactory to the Town, that the building codes have been complied with

Section 5-5.3

Upon failure to comply with Section 5-5, the Chief of Police or Building Inspector or their agent, shall be directed or empowered to cause all activity on the job to cease.

W.C. Martin made the motion this ordinance be adopted by Council, Roy Stroupe seconded the motion was carried by all. Additional specs will be added to the specification sheets on building. It will be mandatory that inspections be made on all buildings.
