mayor is you get to recognize the employees and the staff who work so hard for all of us in town and, and

(*Applause and standing ovation.*) (**) (*Speaking from dais.*) We will not move into the, a, department reports, and the first report is planning, building, and zoning, and I see Ms. Fellner is gonna help us through that."

B. Department Reports

i. Planning, Building, & Zoning.

Ms. Fellner: "Yes, sir. Good evening, Council, Mayor, and citizens. Our director of PB&Z is in training today, and consequently, I'm gonna give the report. There were 88 permits issued this month compared to 90 last year; 51 new business licenses, and staff performed 117 inspection. There were also in February 14 plans reviews. In addition to permits, staff removed several signs located within the right-of-way. Signs belonging to businesses were returned and staff explained the regulations regarding signage within the right-of-way. The next item is congratulations to Kevin Otte for passing his exam and receiving the title of Certified Building Official, and some of you may have noticed..."

Mayor Samples: "Excuse me, Micki, can you pull the, the, a, microphone a little closer? I see
 some people straining."

213 Ms. Fellner: "I'm sorry, I have a cold, and, a, it even makes my voice stranger (laughter.) Some 214 of you may have noticed that Jack O'Quinn has been around. He has begun working with the department 215 performing inspection when the building official is out of the office. This is to prevent any unnecessary 216 delays in the review of plans. So, we are very delighted to have him back. Also the property owner at 217 335 and 339 15th Avenue South had notified us that demolition will begin on the two structures by the end 218 of March or early April, and finally, staff received complaints regarding 633 Sparrow Drive once again. 219 When we sent the building official out to inspect, the front door was open, standing open, and so the 220 building official secured the entrance with a hasp and lock to insure that the abandoned property could 221 not be entered, and there will be, there's gonna be further inspections of this property."

332 Captain Miller: "Good evening, Mayor, Members of Council, we, a, you should have our February 333 report in your packets. To go over some details, we saw some decreases for once in calls for service for 334 the same period of February last year with about a 9.6-percent decrease. We saw an increase in arrests 335 and charge amounts, as well. Those numbers have been provided in detail review in the, a, you know, 336 matrixes in the council packet. We had, a, two reports with uses of force from the patrol division. There 337 was [sic] no injuries to officers. There was one minor injury to a, an arrestee in the jail. Rodney Keziah 338 continues his training at the FBI National Academy. He's nearing completion. He, a, graduates March 339 22nd, and we look forward to him being back the following Monday. Nicole Solorzano, she was our 340 communications officer that transferred over to, a, the patrol division. She is in l believe, her fourth week 341 of training at the South Carolina Criminal Justice Academy. So far her scores have her at just about the 342 top of her class. So, she's doing very well. We're very proud of her. Sergeant Travis Bailey attended a 343 2-day armorer's workshop for Remington shotguns. Again, that's a, a, training that enables him to work 344 on our equipment and a, hopefully, get better service life out of it; not have to replace it. Officers Matt 345 Hoffer and Josh Knight completed a 2-day, 16-hour course of training and 16-hour NCIC operations. This 346 is required for officers to access CJIS and DMV files over their in-car computers. Our new 347 communications officer, Kristy Briggs, she's currently in her field training period, and we expect by the 348 time the next meeting comes up, she will be on her on, and a, working in communications. And, as 349 always, officers maintained their mandatory training and their Class 1 certifications as required by the 350 academy. A couple of notable events, the police department received a very kind letter and certificate 351 from the Special Kid Sponsor Program. As many of you might know, around the holidays they drop by 352 what we refer to as the Christmas tree. It has gifts on it for needy, at risk, abused kids on it, and we, a, 353 there in the police department, we all pretty much chip in and grab a tag off, and a, buy a gift for a child 354 who may need it, and deliver those to the organization. I'm very proud to report that we were able to 355 help, a, over 100 kids through the kindness and generosity of the police department staff. We completed 356 all but one of our annual audits, and we expect that to be completed by the next report; did not see any 357 issues that came up in our audit. We continue the task of redeploying the canine unit. We've had the 358 dog, Dolfy, evaluated with the assistance of the North Myrtle Beach Public Safety Department. Dolfy was 359 found to be in, a, in overall good health and condition to be working, and we're, a, making arrangements 360 to have the actual, a, training, training done. And a, the last, and probably most important part of the 361 report is, a, staff was recently asked to look into and develop a draft or proposed ordinance for the ban of 362 synthetic drugs, often referred to as synthetic marijuana or synthetic bath salts. It's actually a wide range 363 of different substances, and as, and as such it's a very wide and a, a, very varied ordinance that we have 364 presented. We believe that it has a, a very good starting point to addressing the problem, and it's a very 365 real problem, and we recommend that, a, that it move forward to be reviewed by the town's legal staff, 366 and I'm available for any questions that you have."

Mayor Samples: "Thank you, sir. Any questions, comments?"

Ms. Kohlmann: "Mr. Mayor."

Mayor Samples: "Mrs. Kohlmann."

Ms. Kohlmann: "Two, I have two different things. I, I was wondering with our, a, under your calls for service, I see that we have alarm residences. They're usually very high. I was wondering, do you have a program in place where, you must have a lot of accidental trips, and you know, the guys are wasting their time going to these. Do you have a certain set amount and then you either fine the people or not respond?"

Captain Miller: "Yes, we'll always respond, but there is a process where the communications supervisor pulls a report of the alarms. She gets those up to town hall. There is an ordinance that covers false alarms. We try to take into account if an alarm is being worked on, or being tested, and most of the times, people will let us know about that ahead of time. But if it's a case where we see a business or a residence that just habitually has the alarm go, and it's usually with a, a business as opposed to a residence, there is a process under ordinance that a, I believe, you know, town hall administration handles getting those notices sent out for what we call, a, false alarm fees."

Chief." 459 460 Clerk's Note: The written report is on file. 461 462 iii. <u>Fire.</u> 463 464 Chief Cimini: "Good evening, Mayor and Council, residents. The fire department responded to 465 40 alarms in the month of February. To note our volunteers contributed 244 hours total training and the 466 volunteers gave us 190 hours total in activities, fighting fires. Fire prevention activities were 57, which 467 included 19 inspection, 17 re-inspections, and 20 pre-fire plans and updates. Res, we have re, actually increased our ranks of our volunteers by three members this past month, and we've had two new 468 469 applicants that are in the process with the review committee. We hired Lieutenant Prentice Williams as a 470 new shift commander, replacing Greg Faulkenberry. He'll assume the duties of the training officer with, a, 471 Mike Hans moving over to our fire marshal position. We're really pleased to have him. He has 23 years 472 in the fire service, both in the volunteer and career ranks. He's a certified South Carolina Fire Academy 473 Instructor, a South Carolina Fire Marshal, and he is a certified CPR instructor. We just set up the first 474 round of CPR training for our police officers at the end of this month. Our career engineer, Tom 475 Zimpleman, completed his State Fire Marshal certification class and passed, and he also attended the 476 South Carolina Fire Academy for Fire Officer I, and passed that, as well. Two of our volunteers, James 477 Burns, and a, Richard Losko, attended the South Carolina Fire Academy for the fire inspector program. 478 This is a principles type program, the first step in going towards their fire marshal certification. This is 479 kind of a. a. really a. a good program, and it really shows the dedication that our volunteers have, cause 480 this is a weekend away from their families. It's a very extensive course. It's a 16-hour course, and it's, it's 481 followed by a pretty long test. So I was really proud of 'em that they both passed. The vacant engineer's 482 position, we received 19 applicants. We're in the process of reviewing the qualifications. We will have a 483 test, assessment test on the 17th and 18th. It'll include pump operations and aerial operations at the 484 Myrtle Beach fire training center. Myrtle Beach training division will be conducting that test. We'll have a 485 [sic] interview process with five area fire chiefs, followed by a written test and what they call a JRAT, 486 which is a physical agility test. The top three applicants will be presented to a, the town manager [sic] for 487 a follow-up interview and a selection process. One note that I'd like to make is that we have been 488 working on the last two months building a library and a study in the fire station for the firefighters, both 489 career and volunteer. All the, a, furniture, the training manuals, all the books have been gathered through 490 the 1-percent fund, so no taxpayers' money was involved in this one, and that was everybody's effort 491 putting it together to have this facility for our firefighters, and the last thing is, hopefully, all of council 492 changed the batteries on your smoke detectors this past weekend, and we want you to know that our fire 493 department do [sic] have fire, a, smoke detectors that we are willing to give to any resident, including 494 council and mayor. If you don't have one, we'll be happy to come out and install 'em for you. I'll take any 495 questions?" 496 497

Mayor Samples: "You wanna, want to introduce that."

B. All parking spaces that are now or have been added on Ocean Boulevard and any other
 added area need proper definition as to the actual spaces and should be laid out exactly to show
 the general public where the spaces end and begin. As of now there is some real concern by
 citizens and the parking committee where these Ocean Boulevard spaces actually are located.
 Councilmembers Stevens, and Dodge.

910 Mr. Stevens: "Alright, this has come up to me by several citizens. As you drive down Ocean 911 Boulevard and you've got these parking spaces, a, and you look for 'em there's, there's no proper 912 definition of where you're actually gonna park. Where the parking spaces stop or end. A, this is a 913 concern of the parking committee. A, they thought that, a, very, very bad to have parking spaces, but no 914 definition of parking spaces. So I would like to have the town do something that lavs out where these 915 parking spaces are. If we're gonna put parking on Ocean Boulevard, it should be organized, clearly 916 defined so we don't have any problems with whether you're parking here or you're parking there. The 917 only thing that I've seen that any clarity to me [sic] was there was a yellow fence in front of a ditch on 918 Ocean Boulevard on both sides and I knew you couldn't go any further than that yellow fence, so it, it a, 919 think it would be for the best interest of the town and the citizens and also our visitors to have some type 920 of clearly defined parking space if we're gonna have parking on Ocean Boulevard. As it is now, we don't 921 have anything. If we can put wood down, if we can put something that shows where it starts, where it 922 ends, if we can put some type of paint down, or something, if we're gonna have parking spaces on Ocean 923 Boulevard, which a lot of people don't want, even the parking committee didn't want 'em, but I think they 924 need to be clearly and defined, and clearly laid out." 925

Mr. Smith: "Mr. Mayor."

Mayor Samples: "Any other comments? Councilman Smith."

Mr. Smith: "Can we call Mr. Adair to come up and talk to this issue?"

Ms. Kohlmann: "Mr. Mayor."

Mayor Samples: "Let Mr. Adair read the a, read what it is he's gonna be talking to, and then I'm
sure he's, he's considering the comments that he just heard. Mrs. Kohlmann."

937 Ms. Kohlmann: "A, I'm sure that John has a lot of answers for those questions that were brought 938 up already, and as we've all discussed many times, none of us here can direct individually, but since 939 we're here together as a whole. I think it's our job together as a whole, to direct staff sometimes, and in 940 this situation with the parking, a, I would just like to ask if it's not impossible that some kind of, not, not big 941 spectacular drawings, or anything, but some kind of plan in place that we can look at so when we're 942 placing the signs and, and placing the meters, and all, we don't have to go back and redo things that 943 might not necessarily have been done right the first time, and I'm not trying to judge anything or anything, 944 but instead of putting it in and then moving it in two weeks, we're using double manpower, so I know that

staff is, is overwhelmed with everything happening in town. So, I think it would behoove us all to just kind
a say let's have some kind of system or some kind of plan, and I know, I think you have one, right?"

948 Mr. Adair: "Well, I appreciate you saying that, because your, your comment really speaks to the 949 first comment, because this is being laid out in layers over a very short period of time. We had to have a 950 private company create the spots to be made into parking spots. We had to do some delineation. We 951 had to put some signage up, and I say some. We had to put some landscaping in, and again, I say some, 952 and speaking to your point, you don't want to do too much in one area. You want to sort of layer it in to 953 place. When you have a short period of time without a master plan, a, the, the goal is to have clearly 954 delineated spots. The next layer or phase to get done will be delineations, so we don't encroach on the 955 10-foot rule for driveways. We don't encroach on intersection lines, and things like that where it's not 956 clear where the spot begins and ends, we're gonna be putting more, a, materials down on the ground. 957 We, a, everything we put in the right-of-way that wasn't there before was a potential hazard and liability. 958 Everybody needs to, you know, embrace that. Every piece of wood we put down, every sign pole we put up, someone can walk into it, bicycle into it, jog into it, trip over it, it can fall on somebody, so we're trying 959 960 to approach this in a very methodical way with minimal signage to start with. Will more signs be added in 961 the future? Absolutely. Will more delineation go down? Absolutely, Will more landscaping? Absolutely. 962 But, a, that, that's the whole point is, you know, doing haphazardly and without great thought and logic is 963 a bad idea, I think, and that's why the way we're doing it is the way we're doing it." 06/

999 Mr. Stevens: "I reckon the question I have, a, here, is how long will it be, what is your, a, 1000 estimate of how long it'll be before we actually know where each and every parking space is?" 1001 1002 Mr. Adair: "The very next phase, which will start this week, will be laying some more delineating 1003 timbers down to the forward and backward limits of the parking blocks. Not every single parking space 1004 will have forward and rear lines; but where it's going to, where, where it's not clear to the driver of the 1005 vehicle that he's gonna be in violation of the law if he doesn't pull up to that meter, if he hangs back five 1006 feet, he's going be within 10-feet of a driveway, that's the sort of situation that we wanna make it really 1007 clear. When you have very clear four spots in a row and there's, there's no driveways involved, I'm not in 1008 favor of putting five timbers down just to have five rectangles. I think that's hazardous and it'll impede us 1009 from doing our job cutting the grass and things like that." 1010

1011 Mr. Stevens: "Do you have a time date, as the season is coming up on us, do you have a time date when this will actually be done?"

Mr. Adair: "Certainly within the next week or two."

Mr. Stevens: "Next week or two. Now, these spaces, they will be 22-feet long by what?"

1018 Mr. Adair: "We have strived for a 24-foot space with the exception of maybe three or four spaces 1019 that are all 24-feet."

Mr. Stevens: "24-feet by what?"

Mr. Adair: "By 9."

Mr. Stevens: "By 9-feet."

Mr. Adair: "You know, where we've had extra room on the right-of-way we've gone 10 in the 75foot section, just so car doors wouldn't be a problem. But, from 3rd to 3rd we only have 40-feet of right-ofway, so 9 is all we're gonna get."

Mr. Stevens: "How about, I, I know there's been a lot of talk about, a, ordinance that was passed December 10th where we designated that, I think, that we changed line four where it was 10-feet from beach accesses and 10-feet from driveways..."

Mayor Samples: "Which ordinance are you referring to?"

Mr. Stevens: "The parking ordinance."

Mayor Samples: "Oh, okay."

Mr. Stevens: "10-feet from, a, beach accesses, and 10-feet from the driveways, and 10-feet from the entrance to a parking or exit from a parking [sic.] Would that be laid out as well?"

Mr. Adair: "Yeah, it's essentially driveways. (**)"

1046 Mr. Stevens: "I think there was some erroneous information also that was put out to the press 1047 and other people that we changed more than that parking ordinance and I been back and looked it over and over and over and I went back to the January, a, December 10th meeting, and I, I found that the 30-1048 1049 feet from a, a, intersection was already on the law, and that's been on the law since, my understanding, 1050 since two thou, 1996 up to 2009 and that was put out to the press and put out to the media that that was 1051 that was a new law we passed, but that is in effect was not a new law we passed. That was already on 1052 the books. If that law was not on the books then I want a refund of my traf, parking ticket I got for parking 1053 within 30-feet of 5th Avenue North and Hollywood Drive. Thank you." 1054

1059 Mayor Samples: "Mr. Johnson." 1060 1061 Mr. Johnson: "I would just like to say that six members of this council voted to approve this 1062 parking plan, and it came out of nowhere, pretty much, and I think it's asking our public works 1063 department, a, to go above and beyond their duty to try to implement everything at the same time and 1064 keep up all the other projects that they have going on. This man stood up here and told us that prior to, 1065 prior to this that they were up to their ears in work, and so I think it's being a little unrealistic to ask our 1066 public works department to implement everything at one time trying to get it done before the season 1067 starts. That's all I have to say."

1068 1069 Mayor Samples: "Thank you. I, I tend to agree with that line of thinking. Now, just for 1070 clarification purposes, and I don't know who, a, was being referred to about who put what out to the 1071 press, what I do know is that in the fall, Mr. Adair, we tasked Mr. Adair to go down to Ocean Boulevard 1072 and to paint lines at the corners which clearly delineated the, the law at that time, which I agree was 1073 30-feet from an intersection, and, and at that time I thought we were making great progress. But, but, I 1074 think as everybody knows that progress that we made last fall, a, we didn't quite cut it, and now we're 1075 making a light year progress. We're zooming ahead, and, and I, and I, a, want to thank public works for 1076 taking a, a, what I'll call it, what I think is a bad situation, making the best out of it. Again, I want to remind 1077 everybody, a, Councilman Johnson is exactly right. Six of us did vote in favor of that, that a, parking 1078 meters and that sort of thing. One of our great fears was, I know at least on my part, and I'm sure it was 1079 shared by others, was that we're gonna wind up ticketing a lot of people who come to town, who visit who 1080 really don't know what the rules are, and so, and I'll say it again, I think this was a, this is an acceptable 1081 action that we have taken to insure that we are not unfairly ticketing people who do park on Ocean 1082 Boulevard, and I, I can remember when we were even discussing the parking ordinance at the outset, I 1083 was assured by members who, by people who spoke at the podium that there was no intent to eliminate 1084 parking on Ocean Boulevard. No intent. Okay, in fact I called it a, an untoward, I made an untoward 1085 comment, a, about what I perceived, and we haven't. We have not eliminated parking on Ocean 1086 Boulevard. We have clearly identified where it is legal to park now, and I'm sure it'll get better as time 1087 goes by. I, for one, think that landscaping's [sic] the best solution down there. But, we'll just have to wait 1088 and see. Now we'll move to the, a, any other comments on Item B before we move on? That's the third 1089 time I've asked this, so I thought I'd take 10 minutes and lay it out for you. Item number C, this is 1090 Councilman, members Stevens and Kohlmann." 1091

C. Better placement and readability of signs on Ocean Boulevard (a) signs directing the
 general public to designated paid parking meter spaces; (b) signs that clearly shown "no parking"
 in certain areas along Ocean Boulevard, or (c) the immediate placement of plants, bushes and
 trees recommended by the beautification committee to eliminate haphazard and dangerous
 parking by the general public along Ocean Boulevard. Councilmembers Stevens and Kohlmann.

Mr. Stevens: "Why don't you take the lead?"

1099 1100 Ms. Kohlmann: "(**) This is about the better placement and readability of the signs on Ocean 1101 Boulevard. I'm not gonna read your whole paragraph, Randle. I think I can explain it, (**), but I've 1102 already spoken to you about it. The way that that signs that are now there, I'm a little bit confused myself. 1103 They say parking in metered spaces only, but there are stretches that go blocks and blocks that there are 1104 no parking spaces there. So why aren't we just putting no parking sign there so that there is definitely no 1105 confusion whatsoever. People don't look around going where are the meters or if there's no meter there, 1106 then why can't it just say no parking any time? That's my first question. And my second one is I still 1107 believe, and I know there're people in the community that believe, that those signs are too close to the 1108 road. Two feet, I know the laws about the height and, and all that kind of stuff, and, and you had sent an 1109 email out about [sic] a picture about the height, but that's not, for a parking lot height, so that's not for the 1110 road that's travelled by the cars."

1131	spend time moving them all, then it just makes sense that we have some kind of plan. I'm not saying,
1132	again, I'm not saying I want him to come up with something elaborate to give everybody, but say, we're
1133	gonna place these signs on Ocean Boulevard. They're gonna be 2-feet off the road, and then
1134	somebody'll [sic] say well, why don't you put 'em 5-feet off the road, because 2-feet's too close. We're,
1135	we're actually looking for an accident to happen. A, but I think that's a, a big issue and just to, you have
1136	to actually get out of your car now and walk into the middle of the street to see the sign, cause you ca, as
1137	you can't really see it. You have to get out of the car to go look into traffic to see those signs, so I would
1138	like to see us just put them up the right way the first time so it saves you guys a lot of time, and I really
1139	think that no parking signs, I know people don't like it to hear the word no, but if you're gonna be issuing

summonses to people, there's no better way to collect your money than to make it very concise, and I, the reason laws are strict is because there should not be any kind of in between. That's why laws are the way they are. If it says no parking, it's no parking. You get a ticket, you're not gonna fight that. But, you can fight the other one."

Mayor Samples: "Any other comments?"

Mr. Stevens: "Mr. Mayor."

Mayor Samples: "Mr. Stevens."

1151 Mr. Stevens: "Let me continue on in what Ms.. a, Kohlmann was talking about. I also rode down 1152 the road and I've looked at these signs, and they're, they [sic] next to the road. If I swerved over a little 1153 bit, I'd bump it with my truck. A, you cannot read the signs until you get actually upon on 'em, and then 1154 you have to look directly to your right to see 'em. You actually have to stop to see, to see 'em if you want 1155 to read 'em. That's the biggest problem I saw, and a, I was at the, a, BBQ Festival with Councilman 1156 Smith the other day, and a, we were riding by the Yaupon lot and I noticed all the signs, there's about four 1157 of 'em in the Yaupon lot that are all double faced. If, if you're sitting in a normal car like a Honda Accord, 1158 or a Camry, or a little sma, or a truck they're about eye level and you can read 'em from both directions. 1159 The signs we have now, you can't read 'em at all, and in the areas that we didn't, where there's no 1160 parking allowed, there should be something there that, a, when the person is riding down the road, it says 1161 no parking, and you can see that easily. In lieu of the, a, of the no parking signs, then I would suggest 1162 that we take the advice of the beautification committee, and we start putting out shrubbery, trees, and 1163 whatever to keep people from parking in those areas, and a, this, right now it's kind of haphazard, and a, 1164 it doesn't make much sense, because like I said, Ms. Kohlmann's son ran into a sign it was so close to 1165 the road. Those signs are just too close. We need a better placement of signs and better readability." 1166

1169 Ms. Dodge: "Mr. Mayor." 1170 1171 Mayor Samples: "Mrs. Dodge." 1172 1173 Ms. Dodge: "A, I agree about the signs, John. Going on Ocean Boulevard, they were facing 1174 Ocean Boulevard and you had to be right beside them to see the signs, instead of there being turned this 1175 way that as you're driving toward the sign, you couldn't see it till you got there. It should be this way, not 1176 this way. (Hand motions) Does that make sense?" 1177 1178 Mr. Adair: "Absolutely, that's why changes are gonna be made. Is everybody done? Comments? 1179 I can clarify some of this." 1180 1181 Mayor Samples: "Pardon me." 1182 1183 Mr. Adair: I can clarify some of this with responses, if everybody's..." 1184 1185 Mayor Samples: "Please, do." 1186 1187 Mr. Adair: "Well, the placement of signs on the travel way, as it's known, is regulated by the 1188 Manual on Uniform Traffic Control Devices, and there's [sic] parameters that you have to follow. In the 1189 case of the distance from the road, on a street such as Ocean Boulevard, they should be 2- to 5-feet off 1190 of the pavement. We opted for 2.5. Micki and I have rode [sic] the area and we agreed that 4-feet would 1191 probably would be more, more appropriate in the absence of a curb. A, again, you know, putting them up 1192 the right way sometimes, something you, you see after it's done that wasn't the right way. The angle of 1193 the signs. when you're using a double arrow to delineate a parking zone or any sort of regulation, a, 1194 which we have decided to do, the, the angle of the (**) of the sign is 30- to 45-degrees not parallel to the 1195 road and not perpendicular to the road either. We opted for more of a 30-degree stance; 45 clearly would 1196 be more appropriate, so it's more visible to oncoming traffic. So those two issues will be changed. The 1197 height, really shou, should stay where it is. It's right not the bottom of the sign's about 6-feet off the 1198 ground, and in this sort of urban setting where pedestrians or vehicles are likely to be present, they really 1199 like 'em 7-feet off the ground, a, regulatory signs. So the height really is not something that we want to 1200 change. The difference between the road and the angle is something that we're gonna change." 1201 1202 Mayor Samples: "Thank you. Any other questions, comments?" 1203 1204 Mr. Adair: "And again, if I could, just interject, this is one of the reasons why we only put out 27 1205 signs to start with rather than the 75 or 65 that I bought originally, because I wanted to do this in a 1206 measured kind of way to evaluate what make sense." 1207 1208 Mayor Samples: "Very good." 1209 1210 Unknown Speakers: "Mr. Mayor."

Mayor Samples: "Mr. Stevens."

1214 Mr. Stevens: "Alright, Mr. Adair, just, just to a, kind of clarify everything so I'm totally up to date 1215 on everything, and understand this is discussion item, all we're really doing is discussing and getting it out 1216 in the open so we can, you know, these are concerns that have been given to us by citizens, and a, other 1217 people. So we're not trying to, we're not criticizing you, but we're, if you want to say constructive criticism, 1218 okay, we, we just want it to be right and a we hate to see, like Ms. Kohlmann said, you guys come out 1219 here and do the work, and then have to come back and do it again. I think Ross Perot said it best, cut 1220 twice, measure twice, cut once, and a, that's what we're really trying to do, and we just, we know that 1221 you're working hard to do that, and a, a question, has the beautification committee contacted you as far 1222 as where, about putting out bushes, trees, shrubbery along, a, Ocean Boulevard in the areas where 1223 clearly nobody could park, cause they'd be parking on a sidewalk or whatever."

But all three plants were recommended by the beautification committee. We put them initially, and again, in a, in a measured kind of way in places where the area was large enough where somebody might think it was a parking spot, so it would take the place of a sign being there, no parking, and as time goes on, we will fill in with more landscaping beds."

1267 Ms. Mabry: "I do have a, some things I want to say about this. We a, adopted a parking 1268 ordinance and we turned around and adopted the meters, and, and I'm not criticizing anybody. That's the 1269 way it is. It's what it's gonna be. But, we did it all without a comprehensive plan. Now, we're coming 1270 here and we're saying, okay, we want these signs, we want this landscaping, we don't, it's not too late to 1271 get a comprehensive plan. We have a planner that works for the Town of Surfside Beach. She would be 1272 more than happy I'm sure to work with the beautification committee, to work with public works. We don't 1273 have to do everything this year. It might take three or four years to get the whole project implemented, 1274 and we can afford to take that time. So, my recommendation and my hope is that all, that the public 1275 works, that Ms. Morris, that beautification, sit down, develop a comprehensive plan, bring it to council, 1276 and over the years, because we're, that's a living beach; that's a living boulevard; it changes all the time, 1277 that we have the opportunity to see something really wonderful go in. I know that they're doing the best 1278 they can with the short time they've got, but eventually, I would like to see it come with a budget, with a, 1279 the slide show, the whole nine, so, we can have a beautiful boulevard, but we have to do it the right way. 1280 I thank Mr. Adair for making it happen as fast and it's, he's done as much as he could to, a, I'm amazed

that he's done all he can or has done, but a, this is not the way that you run a town. You do things by planning, and there was not a whole lot of planning on this. We just kind of gave it to him and said get it done, season's here. A, that's not fair to him. That's not fair to you. So, I'm hoping that we will sit down and get a great comprehensive plan. That he never feels rushed, that he'll have those projects in the fall, and a, we can get it finished and really make it look beautiful, and thank you for all you do."

1299 Ms. Kohlmann: "I believe that it was put on the agenda, because now we actually have the 1300 ordinance, and we're looking to, a, Captain Miller is now suggesting that we bring it to our legal, the 1301 lawyers for the town to see if we can move forward with this."

Mayor Samples: "Alright."

Mr. Johnson: "Mr. Mayor"

Mr. Johnson: "Town clerk is trying to get your attention."

Mayor Samples: "Yes."

Ms. Herrmann: "Excuse me, I believe at a previous meeting Mr. Smith asked for the ordinance to be brought for discussion before it was sent to legal counsel or brought in ordinance format, but I may be mistaken."

1382	that the chemicals are distributed. There are other states that are addressing that as well. Synthetic

1393 1394 Ms. Kohlmann: "I agree with what you're saying wholeheartedly, and a, having conversations 1395 with other law enforcement agencies across the United States, it's not gonna be easy for our police 1396 department; it's not gonna be easy as a town. A, but when you speak to parents of children that are no 1397 longer here, there are law enforcement officers that have been fighting this battle, and you know, with law 1398 enforcement when you have any kind of new thing, it's, it's test case, and we're gonna be a test case. 1399 So, we're gonna have to struggle through that process, so it's a long process, too. It really is, but the, the 1400 thing is you just don't give up. You can't give up. Cause there's a town in New York, in Oswego, New 1401 York, where kids were dying, because of this drug. They were just dying. And they had to keep going 1402 back to this ordinance and they had to keep fighting to go back to the ordinance, and when I spoke to the 1403 sheriff in Oswego, they don't have the problem anymore. So, it can be done, and I'm a firm believer. You 1404 can do anything in this world, if you put your mind to it, and you work really hard, you really can do 1405 anything. So this council collectively can do a lot, and we're goina show you that we're, we're behind this 1406 to, to help these children, because the children are the future of this town." 1407

Mayor Samples: "Thank you. You know, getting the word out, a, in the community is critical to addressing the issue. I don't think, I know I didn't realize how, how, the level of business was being done. But, it's pretty significant, and it's done, it's done every day. It's probably being done right now. It is legal. There are big time issues involved, but if the people and this council commit to chasing it up the ladder, which is what's gonna have to happen, a, why not do it here. Why not start here, and the General Assembly has dealt with a, the bath salt issues; 29 other states have outlawed this whatever it is, Salvia divnordium..."

Mayor Samples: "...what, whatever, yeah. South Carolina has not. It is our town, and I think that's all we're really responsible for is to try to make our town better. So, I, I applaud everybody for all the efforts, and I wanted to ask, is there any other comments on..."

1426 Ms. Dodge: "I didn't know very much about these types of drugs, but what I read made my hair 1427 turn white, well, whiter. It's like a hydra. You cut off one head, and another one appears, and you cut 1428 that off and another appears, and you've got two determined women up here on this council that are 1429 working on this, and I, I give them a lot of credit. They're not gonna let go, and hopefully, this town will 1430 one that stops it. It'll be a big job."

Mayor Samples: "Um, huh. I, I spoke with Councilman Smith before the meeting, and we had an
infrastructure committee meeting, a, last week, and, and a, he wanted to talk about all the, all the things
we were, I actually asked him if he wouldn't mind briefing everybody, in particular councilmembers, also,
on, on a, just a quick summer of the infrastructure committee meeting."

1441 Mr. Smith: "Okay, this is for the councilmen and also for the community, this is a [sic] update on 1442 the infrastructure committee meeting. One of the things that we did was ask public works to have a 1443 written plan for the stormwater that will be done on the north end next year, and a, notice we said written 1444 plan, and a, a just for your information, the pier ramp and a deck should be completed April the 12th. It's 1445 always good to have a date so as you go down there and watch 'em building that ramp and deck you 1446 know exactly when it's gotta be completed. The telephone poles, electrical poles, on Ocean Boulevard 1447 from 3rd North to 3rd South should be removed before the end of March. We always ask when are those 1448 things gonna actually come down, since we paid a lot of money. Well, by the end of March they'll be

1449 down. Another key thing that was discussed was a the roads that will be a paved this year. The affected 1450 roads should've been already, the neighbors should've been already notified, but I'm gonna mention them 1451 slowly, if I go too fast, you'll have to ask John Adair after the meeting: Dogwood South from 8th South to Melody Lane will be paved; 6th North, Ocean Boulevard to Myrtle will be paved; 8th North, Ocean 1452 Boulevard to Dogwood; 9th North, Ocean Boulevard to Dogwood; 3rd North, Ocean Boulevard to Oak; 4th 1453 North, Ocean Boulevard to Dogwood; 7th South, Ocean Boulevard to Dogwood, and according to public 1454 1455 works' calculation, 44-percent of the paving was on the north side, and 56-percent of the paving is on the 1456 south side. So it's pretty evenly distributed. The other thing that was a big discussion item is where 1457 should the next underground wiring project be; should it be continued on Ocean Boulevard, or should we 1458 go down Surfside Drive. Even though we had a little a vote on it, there's still some flux in that and a, so it 1459 will be presented to council sometime in the future. A, but it's something for folks to start thinking about, if 1460 they want to make comments to council about it, whether it should be on Surfside Drive, the next 1461 underground wiring project, or continue on Ocean Boulevard. And a, to help you understand the, where 1462 the money comes from, the franchise fee is collected on your electric bill. The town gets about \$325,000 1463 per year. This last project, I think, was like \$1.2 million, so it takes \$1.4 million, so it takes three or four 1464 years to get enough money, but Santee Cooper is generous. Once you get a little pile of it, you a, borrow 1465 some from 'em, and a, so that's what we're looking at, and thank you very much." 1466

Mayor Samples: "Thank you, Councilman Smith. Any questions, or comments? Alright, we are
ready then for our five minute public comments, five minutes per speaker on any item related to the Town
of Surfside Beach. Yes, sir."

"Tom Dodge, 1415 Poplar Drive North. In meter city. In the 2/15 town council meeting, Ms. 1473 Fellner presented recommendations from the parking committee. The traffic flow on Seaside Drive South 1474 from 1st Avenue to 3rd Avenue, 4th to 6th, were to become one-way streets. Also, 1st, 3rd, 4th, 5th, 6th 1475 Avenues South were to be one-way from Ocean Boulevard to Seaside Drive. Both the police and fire 1476 1477 departments said this change would be good for maximizing safety. Council voted by a 4:3 margin in 1478 favor of doing this. Let me be totally honest, it is now March 11, 2013 and nothing has been done. 1479 There's no signage and no arrows painted on the roadways. The season is here, folks. Either someone 1480 has failed to do their job or they were directed by someone on this panel not to do it. It's gotta be one or 1481 the other. I came across a, a, an email that, that our mayor sent to a person, and, he says to this person 1482 the adoption of a very stringent parking ordinance. That's not so. It's a safety issue." 1483

Mayor Samples: "It's a matter of interpretation."

Mr. Dodge: "I'm speaking right now, sir."

Mayor Samples: "Go ahead."

1490 Mr. Dodge: "Then now, be quiet. Signage required to alert visitors as well as the residents of the 1491 legal versus illegal parking areas. A, that signage had already put [sic], put in by Mr. Adair before this 1492 memo was written. While I have my doubts about the wisdom of adopting a stringent ordinance on 1493 parking, it is now a town ordinance. Without clear indicators such as meters as to what is legal or not, the 1494 meters were already up, it is very likely that safety of our visitors may result. Our police department and 1495 our fire department said this would be a [sic] maximizing safety. I do not think it is the duty of the mayor 1496 to subvert the wishes of the majority of council. All changes made this spring will maximize safety. Mr. 1497 Mayor, you have not stated the safety of no parking 30-feet from intersections or 10-feet from driveways. 1498 You only say the sky is falling. You are Henny Penny. Be honest and state all the facts. There were 1499 over 40 emails sent to councilmembers. Almost all of them from Surfside Realty properties. Seems like 1500 someone stirred them up. They all were mostly from non-residents. I would like to thank council for the 1501 good work they have done with the metering of Ocean Boulevard and Seaside Drive, and the passing of 1502 the ordinance no parking 10-feet from driveways and beach crossovers. The 30-feet from intersection 1503 has been the law for several years. That is nothing new. It was just never enforced. Thank you, the 1504 boulevard will be much safer now."

1506 "Glen Curtis, 257 Palladium, just west of three feet from 8th Avenue there. A, talk about drugs, 1507 and in the middle 60s when I grew up and I went in service I came home from Nam. I was in a discharge 1508 barracks over in Treasurer Island. I watched an adult that got so hooked on drugs he took red pepper 1509 and wine put it in his arm just to have something there. I, Carol and I, kissed my cousin good bye in a 1510 hospital to go down the parking lot [sic] we were called, he was dead by that short walk down the stairs. 1511 She's an adult, but she got hooked bad. There's adults as well as children in the town that need just as 1512 much help. There's all types of people and there's all types of trunks being opened in different places, a, 1513 along the streets that you can buy tools. You can buy guns. You can buy drugs right out of trunks of 1514 cars. We have to watch out for everything, and I wanted to thank you for what you're doing." 1515

1516 "Good evening. Ralph Magliette, 104 Harbor Lights. First, I just want to say, to change topics 1517 completely, my wife and I, we really love this town, and we think that everyone does the best that they 1518 can and I think that it's a good place to live, and so, what I wanted to come of talk about is something 1519 which I think is a wonderful opportunity and an opportunity would be the potential to build a new senior 1520 center in Surfside Beach. We've had discussions with Mr. Fontaine, who runs the Horry Council 1521 on the Aging, the non-profit who came to our meeting for the senior citizens, and a, at the time he said 1522 that Surfside Beach was either number one or two on the list for a new senior center, and a, it would be a 1523 wonderful addition to our town to have a senior center. Our senior center is very small. It's one of the 1524 oldest senior centers, and they cannot provide the level of services that one would hope that they could 1525 provide, cause it is the former library and it basically is just one room with a, with movable benches and 1526 there is no dedicated facility for, for weights or to do exercises. It doesn't have a kitchen. It does not 1527 have counseling rooms where seniors can get counseling. It does not have any of the new things that the newer senior centers have. (**) go to the Grand Strand Senior Center on 21st Avenue or the new one in 1528 1529 Carolina Forest, you could see the wonderful facilities that are available to seniors, and so. what I'm 1530 asking is, I know it's a long process, is that perhaps as a vision statement or maybe there're some 1531 wonderful people in town, I know that the thing that is needed is to have land to build, to basically build 1532 the senior center in town, and I come from New Jersey where our senior centers were, because of maybe 1533 our area or whatever that we had people who were philanthropic, who either donated money or donated 1534 property, and I was wondering if perhaps to move this project forward maybe a committee could be 1535 formed or maybe we could ask people to maybe potentially donate the property. I know the, a, the 1536 current senior center, which is the library that property was donated by the Calhoun family, and there has 1537 a history of people donating property and money for service, civic pro, projects, and I can't imagine 1538 anything more wonderful to have than to have people donate and we provide a quality of life for our 1539 seniors that live in town, so if there's anything that we could do, as an individual or some type of 1540 committee could be formed, maybe just to maybe move the process forward. I would certainly appreciate 1541 it. A, and a, Mr. Fontaine said since I was gonna come up here and talk that I would be nice enough if I 1542 could just give some senior information out to the councilmembers talking about the senior centers and all 1543 the services that are offered through Horry County Council on the Aging. Thank you very much." 1544

Mr. Magliette (*speaking from floor:* "(**) acres stage of the game for us to move on you basically have to have that piece of property (**) but that something that the council would need to negotiate. Talk to Mr. Fontaine. Initially I was told that they were talking about 10,000 square feet structure (**) because there really isn't a good structure in southern strand to take care of a large senior population. (**) of the land (**) the only cost would be that the town would provide the land. The construction, the facility, the equipment and the staffing would all be taken care of by the Horry County Council on the Aging (**) provide the land (**)."

"Ron Ott. 7th Avenue North. First I'd like to say how blessed we are to have Ralph and his wife 1568 1569 here. They just came here and they, a, championed this cause all by themselves and, and it's really 1570 terrific, and they're, he's unstoppable, which I like. That's really good. A, we, the parking, I've been 1571 sitting back there for two meetings and I think we've put together probably a, a, close to an hour in 1572 discussion and everybody, not meaning everybody, the people sit, sit, sitting in front of me have asked a 1573 couple of times for more clarity. More clarity, more clarity, yet we don't see any plots, diagrams, or 1574 pictures or anything on this screen up here, because I'm getting afraid to go down to the beach. I don't 1575 know what that parking's gonna be. It's, from me just sitting back there listening, it sounds like, wow, 1576 what's gonna go on down here? There's gonna be a lot of tickets, you know. I know, I'm, I'm 1577 exaggerating a little bit, but it's still, we don't have any clarity. What's the problem? Some people like it. 1578 Some people don't. I don't understand it. I, I, I don't, maybe we should have something there to, a, you 1579 know, clarify it for people that are sitting back here. These people back here, the tax payers, residents, 1580 so we can understand what the problem is. Why we've been talking about it in the last two meetings for almost an hour. The other thing is I hope that on, on the 26th we're gonna have a, we're gonna have a tax 1581 1582 increase. Oh, that's the first one I've seen here."

Mayor Samples: "Tax increase?"

1586 Mr. Ott: "Well, it's gonna cost more money for a, for trash, okay, and what I'd like to see is some 1587 kind of breakdown on what has changed in the last few years. Where has this cost be driven, okay, and 1588 I'm gonna ask you for clarification again. That, that's it. The other thing is this synthetic drug, and I have 1589 no idea how it got there, and in the 21st Century where people are afraid they make this, bottled water, 1590 because they might get sued. Why is nobody suing this [sic] people, the people that are selling it? I 1591 mean, we have something that is impairing people, intoxicating people, and it's being sold to do that. 1592 How can they do that? How can they actually be free to sell it under a business license that's issued in 1593 the, in the State of South Carolina, sell something that at its, it's intoxicating, yet we have liquor laws and 1594 everything. We're allowed to do this, and I don't care what molecules are in it, it's impairing people. (**) 1595 that has to be looked at and all these lawyers that we have, and they're, in fact I just seen [sic] the other 1596 night on TV they, the company that makes the red gas cans is out of business, because people sued 1597 them out of business because they were pouring gas on top of fires and it blew up. If you can sue these 1598 people, why can't we sue the guy that sells it? Have the people afraid to sell it, that's where you want to 1599 go, and then it drives it underground. You ain't gonna, you're not gonna stop it, just drive it underground. 1600 Don't make it free and easy to people to look at. You can just walk into a store here in Surfside Beach 1601 and buy something that can be an impaired, you know, can impair your, you know impair everything you, 1602 and then your drive and it's legal. Can't believe that this actually happened. Thank you." 1603

1612Ms. Kohlmann: "Thank you. I'll make it brief, but I do want a make a comment about the, a, or1613it's been coming up every meeting. It comes up in all my emails, and I, I just think I need to address it.1614The ordinance of no parking 10-feet from driveways and 10-feet from crosswalks was, I initiated the1615ordinance. I still firmly believe in the ordinance. As a matter of fact, when I first did the ordinance and1616mailed it out to everybody, one of my responses from somebody on council was okay by me. Simple and

1617 clear change to our ordinance. But now, now, that the parking meters are in place, somehow they're 1618 connected, and they shouldn't be connected. They're two completely different issues. One's an 1619 ordinance and one is parking meters. So, I just think for clarification purposes, and all the emails I'm 1620 getting, nobody wants anyone parked up against their driveway. I haven't met one person that tells me 1621 they want a car parked up against their driveway or up against the, the beach walk. So until people come 1622 and tell me that, this ordinance was too stringent, I still stand behind the ordinance for safety reasons, 1623 and I don't believe that it had anything to do with meters. We didn't have to put meters on Ocean 1624 Boulevard, because we passed an ordinance for safety reasons. We didn't have to do that, and think that 1625 it's not right to give that appearance to the public. That's my opinion. We're all entitled to our own 1626 opinions; however, we're not entitled to our own facts. So I think we need to keep our facts, facts, and 1627 our opinions, our opinions, but when you're giving your opinion as an individual council person to 1628 members of this town, I think you should tread lightly, because it will come back to bite you." 1629

Mayor Samples: "Thank you. Mr. Stevens."

1631 1632 Mr. Stevens: "Ms. Kohlmann, I'm gonna agree 100-percent with you, because the ordinance 1633 never said anything about 30-feet from an intersection. It only said 10-feet from a driveway, 10-feet from 1634 a beach access, and 10-feet from a [sic] entrance to a parking lot or exit from a parking lot. I don't know 1635 how 30-feet got in there, but the 30-feet has been law for years and years and years. I'm living proof of it, 1636 cause I got a ticket last April. The law is not there [sic,] I want a refund!"

Mayor Samples: "Oh, okay. Very good."

1644 Mr. Stevens: "A beginning back, let's talk about letters, and let's talk about emails. We've had a 1645 lot of discussion and people sending emails out on these meters, and I think, well, good God, it must be 1646 really bad, and I'm thinking who are these people sending out emails and who are they from? Well, I 1647 went down and I found out there was Beach Realty, Dunes Realty, Garden City Realty, Harrison Realty, 1648 Old Colony Realty, Philips Realty, Scalise Realty, Seaside Realty and Surfside Realty. Out of 46 emails 1649 and two letters, every complaint came from one realty company, Surfside Realty. I won't say anymore on 1650 that. Speaking of other letters, I got a letter with good news to me. I'm gonna go back in history. On 1651 January 16th, 2013 the South Carolina Ethics Commission met to consider an ethics com, complaint that 1652 was filed against myself by former town administrator. Ed Booth. This complaint alleged that under 1653 Section 8-13-700(a) no public official, public member, (**) et cetera, et cetera, shall attain an economic 1654 interest for himself. The complaint alleged that I, Randle Stevens, used my position as a town 1655 councilman to gain, gain a financial advantage to cash a check that was not otherwise been cashed by 1656 any other citizen. Well, I'm happy to tell you the South Carolina Ethics decision, decision, Ethics 1657 Commission decision after hearing all the facts and complaints on the evidence presented determined 1658 there was not probably cause to indicate that I, Randle Stevens, violated that section, 8-13-700, as I did 1659 not use my position as a Surfside Beach Town Council [sic] to cash a check. Therefore, the South 1660 Carolina Ethics Commission has dismissed all charges in accordance with the laws and as written and I 1661 have been found innocent and have been exonerated by [sic] all the charges in the complaint by, by 1662 former town administrator, Ed Booth. This matter is now a part of public record and a copy of this 1663 decision may be obtained from the South Carolina Ethics Commission or you may request it directly from 1664 myself. - February 2013 Activity <u>(34) New Accounts</u>: New business In-Town (6); New business Out-of-Town (5); New Rentals (16); New Contractors (7); Additional business inquiries (10)
- Business License revenue for February 2013 was \$5,062 which is down from prior year's \$7,812.
- YTD business license revenues are \$45,725 compared to prior year \$72,605 and building permit revenues are \$83,340 down compared to prior year \$119,636, this is mainly attributable to prior year new home construction in Harbor Lights.

Taxes:

Current real estate, personal property and vehicle tax payments received from Horry County for February 2013 were \$33,053, for comparison last year we received \$15,970. YTD collections are \$2,037,393 up from last year's \$2,018,881.

Hospitality & Local Accommodations Taxes:

Hospitality and Local Accommodations taxes received in the month of February were \$16,566 and \$1,878 respectively, which were up slightly from prior year. YTD collections are \$409,622 and \$97,788 compared to last year's \$402,892 and \$99,569.

Enterprise Funds:

In February, the Sanitation Fund collected approximately \$76,479 in service charges, which is down from last year's \$77,976. YTD collections are \$743,702 compared to last year's \$713,378.

RECREATION DEPARTMENT MARCH 2013 MONTHLY REPORT

SPECIAL EVENTS

The BBQ Festival was held on March 9th on Surfside Drive. Entertainment was provided by Sawgrass and the Josh Brannon Band. There were 30 vendors in attendance this year compared to 15 last year. Attendance for this event was estimated at approximately 3,500. Conversations with most of the vendors resulted in a positive comments. Postcards have been mailed to all vendors for feedback. The "Smoke Free" shirts were distributed at no charge at the event. All but a few sizes small and medium are left. Thank you to Anita Crone and Harry Kohlmann for manning the tent. Surveys were completed by 153 people and resulted in the following numbers:

- 84 locals 69 visitors
- 56 male 92 female
- 55 age 64 & up and 37 age 56 to 63 were the largest age groups
- 75 yes and 74 no "Did you come to Surfside Beach specifically to attend this event
- 95 yes and 54 no "Is this your first time attending this event

Also attached is a list of the suggestions for other events and activities people would like to see in Surfside Beach. SAFER (Surfside Area Firefighters and Emergency Responders) prepared and sold the BBQ which resulted in approximately \$3,400.00 profit for this organization.

The St. Patrick's Day Dance was held on Friday, March 15th at the Civic Center. Entertainment was provided by DJs Ed and Irene Brown. Food and beverages were purchased at Sams and provided for the 80 attendees, the largest attendance to date.

Each year during the Christmas holidays the Town receives a "tree" with children's names and a specific gift they are wishing for from The Special Kid Sponsor Program. Employees take a name from the tree and make sure these children have a Christmas. Attached is a letter of thanks and a certificate to the Town from this organization.

Registration for baseball and softball has been completed by the Surfside Beach Youth Sports Association and has resulted in the following teams in each league:

- Softball (age 9 & 10) two teams
- Softball (age 11 & 12) two teams
- Baseball (ages 9 & 10) five teams
- Baseball (ages 11 & 12) five teams
- Baseball (ages 13 & 14) four teams

The softball teams will play a total of 18 games and will travel to play as well as at Huckabee. The baseball teams will play a total of 12 games at Huckabee. All teams consist of 13 players on each team. Regular season begins April 8th. There will be no opening day ceremony but each team will have an "opening" first game. All sponsor signs from last year have renewed and the association has secured 16 new sponsor signs. Plans are in the works for two fundraisers, a community yard sale at a storage facility and a "Ruby Tuesday" night. Registration for T-ball, Coach Pitch and Kid Pitch (ages 4 to 8) begins April 1st at <u>www.surfsidesports.org</u>. The Knights of Columbus will operate the concession stand this year on a 70/30 basis with the Association receiving 70% of the net profits and the Knights of Columbus receiving 30% of the net profits.

PUBLIC WORKS MONTHLY REPORT February 21st – March 20, 2013

SANITATION DIVISION (FTEs - 8)

Residential Service – Eight carts were delivered to accounts; three once the certificates of occupancy had been issued and five due to owners' requests. One cart was repaired and four carts were replaced. Sanitation supervisor responded to six calls regarding ordinance enforcement; eleven calls regarding late put outs and/or questions about bulk/yard debris pick up, fourteen calls involving billing issues, three miscellaneous calls and/or questions and two complaints.

Commercial Service – Service routes continue to be updated based on business needs. Three accounts required extra pick-up services due to overflow. Four businesses were informed that dumpsters needed to be replaced; to date, two have replaced dumpsters. Supervisor explained commercial collection schedules to two new businesses (Grand Strand Credit Corp., Surfside Golf Cart Rentals) and two other new business tenants. Crew responded to three calls regarding ordinance enforcement.

Recycling News – Six carts have been delivered to town residents and businesses upon request. One cart was removed per request. Supervisor responded to four miscellaneous calls with questions about recycling.

Summer Sanitation – Information letters/exemption forms will be mailed out to all sanitation customers within the C-3 and R-3 zoning districts within the next week. Three times a week rollout service is scheduled to begin on May 12^{th} and continue through September 8^{th} .

Scrap Metal – We received a payment of three hundred and four dollars and twenty cents (\$304.20) from Allen's Scrap Metal for metals collected in January/February.

E-Waste – Our next Hazardous Household Waste/Unwanted Electronic Waste drop off event is scheduled for Friday, April 26th through Sunday, April 28th at Public Works.

In February we collected 244.85 tons of solid waste, 31.59 tons of mixed debris, 156.31 tons of yard debris, and 31.97 tons of recyclables.

Crew assisted with the BBQ Festival held on March 9th on Surfside Drive.

STREETS & DRAINAGE DIVISION (FTEs -8)

The Beach – Swash outlets being dug out to ensure proper water flow as needed. Beach trash and recycle cans are being checked and serviced as needed.

On-going/Special Projects:

- Boggs Paving is currently resurfacing several town streets.
- 50/50 Ditch Piping program to date, four projects have been completed and the remaining project will be completed within the next few weeks.
- Repairs/renovations have been completed at the 6th Avenue North Beach Walkover Access.
- Two new Shower Towers are on order and will be installed at 6th Avenue North and 6th Avenue South Beach Accesses before the summer season.
- Street sweeping is being done on Mondays and Fridays, weather and time permitting.
- Crews continue to perform maintenance and clean-up of drainage ditches and catch basins throughout town.

- Dirt is still available free of charge to town residents who come to Scipio Lane and load up the dirt themselves between the hours of 8:00am until 3:00pm on the third Saturday of each month. Those requesting delivery must have the Public Works Director or Street Supervisor inspect the delivery site and issue an inspection ticket confirming proper usage of the dirt prior to placing an order at Town Hall. This inspection will insure that the dirt is not being used to fill in ditches and/or swales that would interfere with our storm water drainage. An appointment can be made to pick up dirt other days by calling Public Works at (843) 913-6360.
- Eight reports were sent to Santee Cooper identifying street lights that were not functioning properly.
- Crew assisted with the BBQ Festival held on March 9th on Surfside Drive.
- From February 21st through March 20th Public Works assistant answered 246 incoming calls. 85 of those calls dealt with sanitation questions/concerns/complaints; 2 calls were from vendors providing product information and/or quotes; 38 calls dealt with street/drainage issues, streetlights, and questions about driveway inspections and dirt delivery; 43 calls dealt with parking meter questions/concerns; 7 calls dealt with parks/grounds issues; 21 were internal calls dealing with department and/or personnel issues and/or questions; 23 calls were received for the Public Works Director; 27 calls dealt with miscellaneous questions, wrong departments and/or telemarketers.

GROUNDS DIVISION (FTEs-4)

- Bids for construction of an ADA compliant restroom at Huckabee were opened on March 18th. Public Works Director Adair is currently reviewing the six bids received for adherence to specifications. Recommendations will be made to Council and the bid awarded upon Council approval.
- Athletic fields at Huckabee and Martin parks are being prepared for the upcoming baseball season set to begin on April 8th.
- Crew assisted with the BBQ Festival held on March 9th on Surfside Drive.
- Crews continue to spruce up Town properties and parks, as well as weeding and trimming.

FLEET MAINTENANCE DIVISION (FTE-2)


From February 21st through March 20th our mechanics completed forty-one (41) repairs on Town vehicles and equipment. Two (2) vehicles had flats repaired, three (3) vehicles had tires replaced, and two (2) vehicles required alignments. Bi-weekly fleet tires checks and fire extinguisher inspections were completed on all Public Works vehicles and/or equipment. "Preventive" and "Scheduled" maintenance (consisting of lube, oil & filter changes, brake inspections, tire rotations and fluid checks) were performed on thirty-one (31) Town vehicles and/or equipment.

- Crew repaired/replaced broken or non-functioning lights at the Pier.
- Crew assisted with the BBQ Festival held on March 9th on Surfside Drive.

<u>PIER</u> – F.E. Baiden & Associates, LLC. continues work on the installation of an ADA ramp and deck expansion at the Pier. Project is expected to be completed by mid-April.

AN ORDINANCE OF THE TOWN OF SURFSIDE BEACH TO REPEAL ORDINANCE #12-0734 TO AMEND SECTION 7-12, SANITATION FEES, PARAGRAPHS 1-4, AND TO ADD SECTION 7-37, PARAGRAPH G, SPECIAL DISPOSAL PRO-BLEMS (E-WASTE)

WHEREAS, the Mayor and Town Council of the Town of Surfside Beach, in council duly assembled on January 22, 2013 adopted Ordinance #12-0734 to amend Section 7-1, Sanitation Fees, Paragraphs 1 through and including 4, and to ad Section 7-37, Paragraph G, Special Disposal Problems (e-Waste); and

WHEREAS, South Carolina Code of Laws Section 6-1-330, Local Fee Imposition Limitations, Paragraph (A) states:

A local governing body, by ordinance approved by a positive majority, is authorized to charge and collect a service or user fee. A local governing body must provide public notice of any new service or user fee being considered and the governing body is required to hold a public hearing on any proposed new service or user fee prior to final adoption of any new service or user fee. Public comment must be received by the governing body prior to the final reading of the ordinance to adopt a new service or user fee. A fee adopted or imposed by a local governing body prior to December 31, 1996, remains in force and effect until repealed by the enacting local governing body, notwithstanding the provisions of this section; and

WHEREAS, South Carolina State Code Section 6-35-130, Notice of Public Hearing; Publication states:

(A) Notice of a public hearing must be published:

(1) once a week for two successive weeks in a newspaper of general circulation within the relevant incorporated municipality; or

(2) once a week for two successive weeks in a newspaper of general circulation within the relevant county.

(B) The notice of public hearing must describe in general terms the location of the proposed district, contain a general description of the proposed improvements, identify each owner of twenty-five percent or more by acreage of the real property situated in the area of the proposed district, and state the date, time, and place of the public hearing.

(C) The final publication must be at least ten days before the date of the scheduled public hearing. At the public hearing and at any adjournment of the meeting, all interested persons may be heard either in person or by attorney.

NOW, THEREFORE, in order to comply with the cited South Carolina State Code, the Mayor and Town Council hereby repeal Ordinance #12-0734 to amend Section 7-1, Sanitation Fees, Paragraphs 1 through and including 4, and to ad Section 7-37, Paragraph G, Special Disposal Problems (e-Waste) and said Ordinance #12-0734; and

FURTHER, that pursuant to South Carolina Code Sections 6-1-300 and 6-35-130, et seq, a public hearing shall be advertised and held prior to second reading of Ordinance #13-0741 to amend Section 7-1, Sanitation Fees, Paragraphs 1 through and including 4, and to add Section 7-37, Paragraph G, Special Disposal Problems (e-Waste).

SEVERABILITY. If any provision, clause, sentence, or paragraph of this ordinance or the application thereof to any person or circumstances shall be held invalid, that invalidity shall not affect the other provisions of this article, which can be given effect without the invalid provision or application, and to this end the provisions of this article are declared to be severable.

EFFECT OF SECTION HEADINGS. The headings or titles of the several sections hereof shall be solely for convenience of reference and shall not affect the meaning, construction, interpretation or effect of this ordinance.

REPEAL AND EFFECTIVE DATE. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed. This ordinance shall take effect immediately upon approval at second reading by the Town Council of the Town of Surfside Beach, South Carolina.

BE IT ORDERED AND ORDAINED by the Mayor and Town Council of the Town of Surfside Beach, South Carolina, in assembly and by the authority thereof, this 25th day of March 2013.

AN ORDINANCE OF THE TOWN OF SURFSIDE BEACH TO AMEND CHAPTER 7 OF THE TOWN'S CODE OF ORDINANCES TO REVISE DIVISION 2, §7-12, ¶1-4, AND INCLUDE IN DIVISION 3, §7-37, ¶G, SPECIAL DISPOSAL PROBLEMS (E-WASTE)

WHEREAS, the Mayor and Town Council of the Town of Surfside Beach, in council duly assembled adopted The Town's Code of Ordinances, to include Section 1-12 which allows for the amendment of the code when the public necessity, convenience or general welfare justify such action; and

WHEREAS, the Mayor and Town Council has determined that the facts and findings provided to them support the recommendations to have the above sections amended,

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS that Chapter 7 of the Town's Code of Ordinances, Division 2 Section 7-12 Paragraphs 1-4 and Division 3 Section 7-37 be amended to add Paragraph (g) to read:

DIVISION 2 SECTION 7-12 ¶1-4

Sec. 7-12. - Service charges.

(1) *Mobile container service*. Mobile refuse container service shall be charged at the rate of eighteen dollars and 75 cents (\$18.75) per month per cart for all customers serviced by the town.

(2) Roll-out curb service.

(a) Summer roll-out curb service. Mandatory rollout curb service shall be in effect for transient rental properties, i.e., rentals less than thirty (30) days, which are deemed commercial operations, located within the R-3 and C-3 zoning districts, from the second Sunday in May through the first Sunday following Labor Day at the rate of seventy-six dollars and twenty-five cents (\$76.25) per month per cart. This charge is broken down as follows: \$18.75 x 3 time per week service= \$56.25; plus \$20 summer service charge.

(b) <u>Winter Roll Out Curb Service</u> of \$12.00 dollars per month shall be optional for the total R-3 district and shall be mandatory for the total C-3 district.

Persons or properties who want to opt out of the Winter Roll Out Curb Service in the R-3 district shall notify the Town of Surfside Beach Public Works Department. This notification shall be made each and every year that a person or property want to opt out of the Winter Roll Out Curb Service to the Surfside Beach Public Works Department.

Failure to notify the Surfside Beach Public Works Department shall result in that person or property in the R-3 district being charged a Winter Roll Out Service of \$12.00 dollars per month.

If a cart for a person or property that has opted out of the Winter Roll Out Services is rolled out to the street and the person or property fails to remove the cart from the street, or if waste or garbage becomes a health or safety hazard, the Surfside Beach Public Works Department can reinstate the Winter Roll Out Service fee of \$12.00 dollars without notifying the person or property who chose to opt out, this action shall be at the discretion of the public works director or his designee.

Winter Rates shall be a price of \$30.75, broken down at \$18.75 per month plus a \$12.00 dollar Winter Roll Out Curb Service fee from the second Wednesday after Labor Day until the second

<u>Wednesday in May</u> at the rate of \$12.00 per Month per Cart for the Roll Out Curb Service for transient rental properties, i.e., rentals less than thirty (30) days, for properties in the C-3 and R-3 districts."

Exception: Year-round resident owners of multi unit homes are exempt from summer roll-out curb service for rental units that are attached to their primary residence, provided that Moby carts for the rental units located on the property are curbside at the appointed times. Should said resident owner fail to place Moby carts curbside at the appointed time, the town reserves the right to require the owner to participate in summer roll-out service as set forth herein.

(3) Exemption from rollout curb service. Owners of noncommercial properties in the R-3 and C-3 zoning districts must provide written notification to the Town of Surfside Beach of either permanent residency or non-rental status. This notification must be made each year to the town. Acceptable forms of notification shall include a valid South Carolina driver's license with address of property within town limits to establish residency, a copy of a current lease for a rental property within town limits, or a signed notification of noncommercial use.

(4) Bulk containers service. Bulk container service shall be charged at the rate of twenty-six dollars and twenty-five cents (\$26.25) per container per pickup for 6-yard containers and thirty-one dollars and seventy-five cents (\$31.75) per container per pickup for 8-yard containers.

DIVISION 3 SECTION 7-37 ¶(g)

Sec. 7-37. - Special disposal problems

(g) Electronic Waste (E-scrap). Effective July 1, 2011 – residents may not knowingly place or discard a computer, computer monitor, printer or television, or component of same, in any waste stream that is to be disposed of in a solid waste landfill. The Town will not collect these items with regular refuse after this date.

WHEREAS, the Mayor and Town Council of the Town of Surfside Beach, in council duly assembled on February 26, 2013 desire to repeal the franchise agreement stipulated Article IV, General Telephone Company of the Southeast Sections 1 through 15; and

WHEREAS, said franchise agreement expired on October 7, 2007; and

WHEREAS, the said General Telephone Company of the Southeast was purchased by Verizon Telephone in 2001 and is no longer a legal entity.

NOW, THEREFORE, Appendix Article IV, General Telephone Company of the Southeast, Sections 1 thorough and including 15 are hereby repealed; and

BE IT FURTHER KNOWN, that Article IV shall be reserved for future use.

Minutes of Meeting held 2/20/2013 - see item 4 below. Also present were Mary Beth Mabry, Julie Samples and Harry Kohlmann. Mayor Samples, Sabrina Morris (PB&Z) and John Adair (PW) departed after speaking.

Motion to _____No formal motions were made at this meeting.

Vice Chair Peggy Sattelmeyer chaired the meeting. The group acknowledged the resignations of Jim Toney, Shelby Smith, Jerry Strange and Mary Ann Hunt from the KSBB Committee. Ms. Sattelmeyer stated that in order to have a fresh start, she would resign as Vice Chairperson and the group would elect all new officers during this meeting. Mary Ellen Abrams filled in as secretary. There was a brief discussion to the effect that remaining members feel the current size of the group is sufficient and that new members need not be recruited.

1. Sabrina Morris, Director of Planning, Building and Zoning, passed out a draft ordinance on Nuisance. She gave a brief explanation and asked for KSBB members' individual comments within a week.

2. Election of Officers: Members were asked to volunteer for Chair, Vice Chair or Secretary. (The committee had been advised previously that Nancy Jo Weber would accept a position and that Dora Eaddy would not be interested in a position). Nancy Jo Weber was selected as Chairperson, Ronald Gaskins was selected as Vice Chairperson and Peggy Sattelmeyer was selected to be Secretary – all by unanimous acclamation.

3. John Adair, Director of Public Works, gave a brief update on beautification projects.

4. Future Plans/Projects for KSBB.

-The Directors of Public Works and of Planning, Building and Zoning were asked to think about ways in which KSBB could assist them in their responsibilities.

-Peggy Sattelmeyer displayed a self-watering hanging flower basket for possible use on light poles throughout the town. She is going to test the amount of maintenance required before KSBB recommends that the town purchase them in quantity.

- Mayor Samples spoke briefly about the need for cleanup efforts in areas other than the beach. The committee agreed that this suggestion ties in with the requirement by Palmetto Pride that the town hold a Great American Cleanup event between March 1 and May 31 of this year. Ron Gaskins will represent KSBB in working with the Director of Public Works to plan such an event, perhaps on a small scale since time is short.

5. Discussion of draft minutes from February 20, 2013. There was no quorum on that date; therefore there will be no minutes. Several items discussed at that meeting were reviewed and determined to be resolved (i.e., retain existing palm trees at beach accesses; 16th N at Magnolia Lake is a budget item; Cedar Drive N between the 2 lakes is a budget item; "Adopt-A-Palm"/bulk purchase – sporadic approach not feasible.)

6. March 31, 2013 KSBB Quarterly Report to Town Council. Peggy Sattelmeyer will disseminate a final draft by email and if there are no comments it will be submitted to the Town Administrator.

7. Each subcommittee gave a brief update.

8. New Business: Ralph Magliette proposed a town event involving children searching the town for the largest Live Oak tree. KSBB suggested that he make that proposal to the Special Events Committee.

9. It was decided that a mid-month meeting will not be necessary. The next meeting of KSSB will take place on April 17, 2013.

Meeting was adjourned at 2:35 p.m.

AN ORDINANCE OF THE TOWN OF SURFSIDE BEACH TO AMEND SECTION 9-16 DECALS AND EXEMPTIONS FOR PARKING DECALS RELATING TO NONRESIDENT RESIDENTIAL PROPERTY OWNERS, AND COMMERCIAL BUSINESSES GOLF CART OPERATION

WHEREAS, the Mayor and Town Council of the Town of Surfside Beach, in council duly assembled desire to establish a policy relating to the issuance of parking decals allowing resident and* nonresident residential property owners to park their vehicles and golf carts in metered spaces when available without charge; and

WHEREAS, the Mayor and Town Council desire to establish that commercially owned golf carts rented for profit shall be identified as such by decals and operators there of shall be required to park in metered spaces and make appropriate payment

NOW, THEREFORE, Section 9-16, Decals and Exemptions of the Code of Ordinances of the Town of Surfside Beach, South Carolina, is hereby amended to read as follows:

Sec. 9-16. – Decals and exemptions

(a) <u>Resident and Nonresident Residential Property Owner Parking Decals</u> cals issued for full time resident and non-resident residential property owner vehicles including golf carts. All persons residing or owning residential property within the corporate limits of the town shall be entitled to one (1) free decal per vehicle, to be issued by the town, upon verification of current vehicle registration or verification of proof of residential property ownership. Such decal will be placed on the vehicle pursuant to instructions given by town hall staff when obtaining the decal. The decal shall be valid for the calendar year in which issued. Said decal will show: (1) decal number issued, and (2) year for which decal is valid. Such decal shall allow a resident and residential property owner to park free of charge in metered or pay station areas when space is available.

(b) <u>Golf Cart Registration Required.</u> Registration and businesses owning golf carts within the corporate limits of town, including those entities which may lease, lend, borrow, or purchase golf carts for the purpose of renting to the public, shall register golf carts with the town police department. Proof of ownership and liability insurance is required.

(i) **Residents and nonresident residential property owners** shall pay a fee of two dollars (\$2.00) per golf cart. Decals shall be distinguished by blue lettering on white background. Decals shall allow residents and nonresident propression to park in golf cart parking, and "permit only" parking areas frand in metered spaces areas areas from the space is available.

(ii) **Commercially owned** golf carts shall be charged a fee of five dollars (\$5.00) for each golf cart, Decals shall be distinguished by white lettering on a red background. The registration decal shall state "Pay Parking Only," meaning that operators of commercial golf carts must park in metered spaces and pay applicable fees for parking.

Decals shall be placed by police staff in such a manner that will enable the registration decal to be clearly visible to the operator of the golf cart while being operated. The issued decal will show: (1) registration number; (2) years for which decal is valid, and (3) all applicable golf cart rules.

If any provision, clause, sentence, or paragraph of this ordinance or the application thereof to any person or circumstances shall be held invalid, that invalidity shall not affect the other provisions of this article, which can be given effect without the invalid provision or application, and to this end the provisions of this article are declared to be severable.
