1. CALL TO ORDER.

Mayor Childs called the special meeting to order at 12:00 p.m. Mayor Childs, Mayor Pro Tempore Ott, and Councilmembers Courtney, Johnson, Pellegrino, and Stevens were in attendance. One seat is vacant. A guorum was present. Others present: Administrator Fellner and Town Clerk Herrmann.

2. PUBLIC COMMENTS – AGENDA ITEMS. (3 minutes).

15 16 Ms. Betty Lowery, 4th Avenue North. You're going to be going into executive session. It is my 17 understanding that executive session is so that you can meet on confidential items having to do with 18 personnel, or finances, or legal matters so that you can discuss openly and privately what may be going 19 on, and that what is discussed in executive session should not be discussed [outside of] executive 20 session; should not be shared outside of that. It took me probably 30 minutes after the last executive 21 session to know what had happened and what had been said. Now, I know when rumors are spread that 22 the people who share them usually want to prove that they are insiders; that they know things that other 23 people don't know, and they are trying to prove that to the person they share it with. The objective of 24 what I'm saying right now is that we've had a lot of executive sessions lately. I just want to remind 25 those of you have been sitting for a while that this is a private thing. If everything is going to be shared, 26 there's no point in executive session. You can do it right up there [on the dais.] If you're going to share 27 it, then you're breaking confidentiality that should not have happened. If you're here for the personal 28 power and it makes you feel good to share this kind of stuff, you know, nobody can stop you. But, it 29 makes you look bad. It makes you look bad [sic.] If personal power is what it's all about, you don't 30 really have any business [on council.] Thank you. 31
